Attached is a photocopy of a "**NOTICE TO THE PUBLIC**" from the Office of the President (OP), dated 21 November 2017 giving the public information on unscrupulous individuals posing as members of the Cabinet, including the Executive Secretary, or name-dropping the latter in fraudulent schemes to solicit funds from the public.

The public is also warned that the OP and the Office of the Executive Secretary (OES) have not authorized any person to solicit money or other things of value from the public for the alleged benefit of Marawi soldiers, senior citizens, illegal drug campaign, or any other cause, for that matter.

In this connection, the Prosecutor General, all Heads of Bureaus, Commissions and Offices attached to the DOJ, this Department's Administrative and Management Information Services Divisions are hereby directed to give this *Notice* the **widest dissemination such as posting in conspicuous places in all offices including agency websites.**
