## RESOLUTION

### **RECOMMENDING THE AWARD OF CONTRACT TO COPYLANDIA OFFICE SYSTEMS CORPORATION FOR THE REPAIR OF PHOTOCOPIER MODEL DEVELOP INEO423 FOR THE USE OF THE INTER-AGENCY COUNCIL AGAINST TRAFFICKING**

**WHEREAS**, there is an urgent need for the repair of photocopier model Develop Ineo423 for the use of the Inter-Agency Council Against Trafficking (IACAT) of the Department of Justice (DOJ);

**WHEREAS**, the procurement for repair and maintenance of various DOJ equipment is included in the approved FY 2019 Annual Procurement Plan (APP), in the amount of Four Hundred Twenty Thousand Pesos (P420,000.00);

**WHEREAS**, in a Memorandum dated 26 July 2019 of Ms. Aubrey V. Bastareche-Lucero, IACAT Executive Officer, it was stated that Copylandia Office Systems Corporation is the exclusive distributor of INEO Photocopiers and Parts;

**WHEREAS**, the total cost for the repair of photocopier model Develop Ineo423 is Fifty-Seven Thousand Two Hundred Eighty-Seven Pesos (P57,287.00);

**WHEREAS**, direct contracting<sup>1</sup> may be resorted to when the procurement of critical components from a specific supplier is a condition precedent to hold a contractor to guarantee its project performance, in accordance with provisions of its contract or those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GOP;

**NOW THEREFORE**, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to Copylandia Office Systems Corporation, in the amount of Fifty-Seven


