## RESOLUTION

### A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO SEDA ATRIA HOTEL FOR LEASE OF VENUE FOR THE CONDUCT OF GENDER AND DEVELOPMENT (GAD) SEMINAR WORKSHOP, DIVERSION ROAD, MANDURIAO, ILOILO CITY.

**WHEREAS**, there is a need for a venue for the conduct of Gender and Development (GAD) Seminar Workshop to be held on 28-29 November 2019 in SEDA Atria Hotel, Iloilo City;

**WHEREAS**, the procurement for the lease of venue for the said event is included in the approved FY 2019 Annual Procurement Plan (APP) with allotted budget of **One Hundred Sixty Thousand Pesos (P 160,000.00)**;

**WHEREAS**, the conduct of said event is to apprise the participants of the basic gender issues and gender sensitivity. This activity also aims to remove actual and potential gender biases by focusing on the principle development for all.

**WHEREAS**, pursuant to the procedures for lease of privately-owned real property and venue, the department requested three (3) establishments to submit quotations, namely: **SEDA Atria, Hotel del Rio, and Smallville 21 Hotel**, to wit:


**WHEREAS**, among the three (3) establishments that submitted its quotations,


