RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO PHILIPPINE INTERNATIONAL CONVENTION CENTER FOR THE CONDUCT OF THE LAUNCHING OF THE 2019-2022 COMPREHENSIVE PROGRAM FOR CHILDHOOD PROTECTION HANDBOOK ORGANIZED BY THE COMMITTEE FOR THE SPECIAL PROTECTION OF CHILDREN TO BE HELD ON 21 NOVEMBER 2019

WHEREAS, there is a need for a venue for the conduct of the Launching of the 2019-2022 Comprehensive Program for Child Protection (CPCP) Handbook organized by the Committee for the Special Protection of Children (CSPC) to be held on 21 November 2019;

WHEREAS, the procurement for the lease of venue for the said event is included in the CY 2019 Supplemental Annual Procurement Plan No. 6 (SAPP 6) with an allotted budget of Eighty Thousand Pesos (P80,000.00);

WHEREAS, pursuant to the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184, it is the policy of the government to give preference to publicly-owned real property or venue over privately-owned real property or venue, insofar as the lease of real property or venue for official use is concerned¹;

WHEREAS, the Philippine International Convention Center (PICC) is a government-owned institution, constructed pursuant to Presidential Decree No. 520 (s. 1974), as amended, as an international conference center suitable for the holding of international conferences, meetings, and similar undertakings;

WHEREAS, based on the aggregate charges sheet submitted by PICC, the total cost of lease of venue for the said activity, including the use of meeting room, meals and other requirements, is Seventy-One Thousand Pesos (P71,000.00);

NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby
