## RESOLUTION

### **A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO FRANCISCO'S REFRESHMENT FOR CATERING SERVICES ON THE REGIONAL YEAR-END EVALUATION AND RECOGNITION, ILOILO SPORTS COMPLEX COVERED GYM, LAPAZ, ILOILO CITY CAMPUS**

**WHEREAS**, there is a need for a lunch for the conduct of Regional Strategic Planning Session and Year-End Evaluation and Recognition to be held on 20<sup>th</sup> of December, Iloilo Sports Complex Covered Gym, Lapaz, Iloilo City;

**WHEREAS**, the procurement for the lunch for the said event is included in the approved FY 2019 Supplemental Annual Procurement Plan (SAPP) with allotted budget of **One-Hundred Eighty-Eight Thousand Pesos (P 188,000.00)**;

**WHEREAS**, the conduct of said event is will be the first ever activity of it's kind to be organized by the Office of the Regional Prosecutor. These activities will be attended by the City and Provincial Prosecutor's and Administrative Staff in the region. This will be an opportunity to align all the processes, and recalibrate immediate and long-term goals in the region. **WHEREAS**, pursuant to the procedures for the procurement of meals (AM Snack, Lunch, PM Snacks and Dinner), the department requested three (3) establishments to submit quotations, namely: **Francisco's Refreshment, Merci Food House and Carmen Eatery and Grillers**, to wit:

**WHEREAS**, among the three (3) suppliers that submitted its quotations, and based from the rating factors submitted by the end-user, **Francisco's Refreshment** provided the lowest calculated and responsive quotation;



**RESOLVED** this 10<sup>th</sup> of December 2019 at the Regional Prosecutor's Office, Iloilo City, Region VI.




