RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO APPCENTRIC SOLUTIONS INCORPORATED FOR THE PROCUREMENT OF SINGLE CARPETA SYSTEM ENHANCEMENT

WHEREAS, there is a need for procurement of single carpeta system enhancement;

WHEREAS, the DOJ posted its Invitation to Bid for the aforesaid purchase in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 16 September 2020;

WHEREAS, the purchase of the said items is included in the CY 2020 Supplemental Annual Procurement Plan No. 4 (SAPP 4) with an allotted budget of Four Million Eight Hundred Ten Thousand Pesos (P4,810,000.00);

WHEREAS, the Approved Budget for the Contract is Four Million Eight Hundred Thousand Pesos (P4,800,000.00);

WHEREAS, in response to the said invitation, three (3) prospective suppliers submitted their bids in a public bidding (*via google meet*) held on 8 October 2020, 10:00 a.m., to wit,

WHEREAS, on 8 October 2020, Microbase, Inc. filed a motion for a reconsideration of its submission of a copy of their SLCC itself and just a statement of SLCC, alleging the following facts:

- a) Bidding documents submitted via online was based on the Supplemental Bid Bulletin (SBB) No. 1 – Bid Submission File Guide,
- b) In SBB No. 1 – item #3.b, it states: ongoing.pdf – scanned copy of statement of prospective bidder's all ongoing government and private contracts, including contracts....., and
- c) In SBB No. 1 – item #3.c, it states: slcc.pdf, scanned copy of the bidder's SLCC – there is no mention of inclusion of a statement of SLCC

WHEREAS, in meeting held for the purpose on 16 October 2020, the Bids and Awards Committee resolved to grant the motion for reconsideration and accept a copy of the SLCC itself as compliance to the requirement of a statement of SLCC;

WHEREAS, the continuation for the opening of financial bid of Microbase Inc. was scheduled and held on 21 October 2020, and showed a bid of P4,798,000.00;

WHEREAS, the aforesaid bids were referred to the DOJ Bids and Awards Committee-Technical Working Group (BAC-TWG) for evaluation and post-qualification, with the following findings:


WHEREAS, the DOJ BAC-TWG, after review and evaluation, finds that Appcentric Solutions Incorporated submitted the lowest calculated bid, was found to be compliant and is legally, financially and technically capable to undertake the subject procurement;

NOW THEREFORE, after thorough deliberation, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to **Appcentric Solutions Incorporated**, in the amount of **Three Million Seven Hundred Five Thousand Pesos (P3,705,000.00)**, for the procurement of single carpeta system enhancement, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
