RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO CUP OF KINDNESS ENTERPRISES FOR THE PURCHASE OF OFFICE OF CYBERCRIME SEAL AND PAPERWEIGHTS

WHEREAS, there is a need for the purchase of Office of Cybercrime seal and paperweights;

WHEREAS, the purchase of the aforementioned goods is included in the CY2020 Supplemental Annual Procurement Plan No. 1 (SAPP 1);

WHEREAS, the Approved Budget for the Contract under Small Value Procurement is P90,000.00

WHEREAS, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for six (6) calendar days and was sent to three (3) prospective suppliers, namely: Cup of Kindness Enterprises, Skylite Creative Team for Creative Projects and MG and Global Ads, Inc.;

WHEREAS, in response to the said invitation, only one (1) prospective supplier submitted its quotation, to wit,

WHEREAS, after review and evaluation, BAC-TWG found Cup of Kindness Enterprises to be legally, financially, and technically capable to undertake the subject procurement, having submitted the Single Calculated and Responsive Quotation (SCRQ);

WHEREAS, considering that the amount involved in the subject procurement is **EIGHTY-EIGHT THOUSAND SIX HUNDRED FORTY PESOS (P88,640.00)**, an alternative mode of procurement is allowed by GPRA,

provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of resort to alternative mode of procurement thru Small Value Procurement, and further recommend the award of contract to **CUP OF KINDNESS ENTERPRISES** for the purchase of Office of Cybercrime seal and paperweights in the amount of **EIGHTY-EIGHT THOUSAND SIX HUNDRED FORTY PESOS (P88,640.00)**.
