RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO JBD MULTIMEDIA PRODUCTION SERVICES FOR THE RENTAL OF AUDIO & VIDEO EQUIPMENT AND LED WALL FOR THE DEPARTMENT OF JUSTICE CHRISTMAS PARTY ON 18 DECEMBER 2020

WHEREAS, there is a need for the rental of audio & video equipment and LED wall for the Department of Justice Christmas Party on 18 December 2020;

WHEREAS, the purchase of the aforementioned goods is included in the CY2020 Annual Procurement Plan;

WHEREAS, the Approved Budget for the Contract under Small Value Procurement is P160,000.00;

WHEREAS, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for four (4) calendar days;

WHEREAS, in response to the said invitation, two (2) prospective suppliers submitted their quotations, to wit,

WHEREAS, after review and evaluation, BAC-TWG and upon issuance of a certification by the end-user, found JBD Multimedia Production Services to be legally, financially, and technically capable to undertake the subject procurement, having submitted the Lowest Calculated and Responsive Quotation (LCRQ);

WHEREAS, considering that the amount involved in the subject procurement is **ONE HUNDRED FIFTY FIVE THOUSAND PESOS (P155,000.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of Small Value Procurement as an alternative mode of procurement, and the award of contract to **JBD MULTIMEDIA PRODUCTION SERVICES** for the rental of audio & video equipment and LED wall for the DOJ Christmas Party on 18 December 2020 in the amount of **ONE HUNDRED FIFTY FIVE THOUSAND PESOS (P155,000.00)**.
