## **RESOLUTION**

### **RECOMMENDING THE AWARD OF CONTRACT TO MANILA BULLETIN PUBLISHING CORPORATION FOR THE ADVERTISEMENT RELATIVE TO THE COMMEMORATION OF THE NATIONAL ALTERNATIVE DISPUTE RESOLUTION DAY ON 19 DECEMBER 2020**

**WHEREAS**, there is a need for the advertisement in the newspaper of general circulation relative to the commemoration of the National Alternative Dispute Resolution day on 19 December 2020;

**WHEREAS**, the purchase of the aforementioned goods is included in the CY2020 Annual Procurement Plan (APP), with an allotted budget of Five Hundred Thousand Pesos (P500,000.00);

**WHEREAS**, pursuant to the rules on *Negotiated Procurement-Procedures for Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services*<sup>1</sup>, the Department conducted a market study wherein the following entities submitted quotations, namely: The Philippine Star, The Manila Bulletin, and The Philippine Daily Inquirer;

**WHEREAS**, the result of the proposals submitted as shown in the abstract of bids, are as follows:

**WHEREAS**, after evaluation by the DOJ Bids and Awards Committee-Technical Working Group, it appears that The Manila Bulletin submitted the lowest calculated & responsive bid and was found to be compliant and is legally, financially and technically capable to undertake the subject advertisement;
