RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO THE ARISTOCRAT RESTAURANT FOR THE PURCHASE OF PACKED LUNCH AND SHAKEY'S PIZZA VENTURES INC. FOR THE PURCHASE OF PM SNACK IN CONNECTION WITH THE DEPARTMENT OF JUSTICE CHRISTMAS PARTY ON 18 DECEMBER 2020

WHEREAS, there is a need for the purchase of packed lunch and PM snacks in connection with the Department of Justice Christmas Party on 18 December 2020;

WHEREAS, the purchase of the aforementioned goods is included in the CY2020 Annual Procurement Plan;

WHEREAS, the Approved Budget for the Contract under Small Value Procurement is P350,000.00 and P175,000.00 respectively;

WHEREAS, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for six (6) calendar days and was sent to four (4) prospective suppliers, namely: The Aristocrat Restaurant, Max's Kitchen Inc., Savory Fastfood Incorporated and Kenny Rogers Restaurant;

WHEREAS, in response to the said invitation, five (5) prospective suppliers submitted their quotations, to wit,

WHEREAS, the 2020 DOJ Christmas Party host, Legal Staff and BAC-TWG conducted food tasting on 11 December 2020 to determine the best offer of The Aristocrat Restaurant, Shakey's Pizza Asia Ventures Inc., Max's Kitchen Inc., Savory Fastfood Incorporated and Sweet Onion Cuisine & Catering Services Corp. and were rated on the following criteria: Food

Presentation/Serving – 20 points, Taste – 60 points, and Past Experience/Track Record – 20 points.

WHEREAS, after review and evaluation, BAC-TWG and upon recommendation by the 2020 DOJ Christmas Party host, found The Aristocrat Restaurant and Shakey's Pizza Asia Ventures Inc. to be legally, financially, and technically capable to undertake the subject procurement, having submitted the Lowest Calculated and Responsive Quotation (LCRQ);

WHEREAS, considering that the amount involved in the subject procurement is **THREE HUNDRED FIFTY THOUSAND PESOS (P350,000.00)** and **ONE HUNDRED SEVENTY FIVE THOUSAND PESOS (P175,000.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of Small Value Procurement as an alternative mode of procurement, and the award of contract to **THE ARISTOCRAT RESTAURANT** for the purchase of packed lunch in the amount of **THREE HUNDRED FIFTY THOUSAND PESOS (P350,000.00)** and to **SHAKEY'S PIZZA ASIA VENTURES** for the purchase of PM Snacks in connection with the DOJ Christmas Party on 18 December 2020 in the amount of **ONE HUNDRED SEVENTY FIVE THOUSAND PESOS (P175,000.00)**.
