## RESOLUTION

### RECOMMENDING THE AWARD OF CONTRACT TO VJ GRAPHIC ARTS, INC. FOR THE PRINTING OF VWC THERAPEUTIC JOURNAL

**WHEREAS**, there is a need for the printing of VWC Therapeutic Journal;

**WHEREAS**, the purchase of the aforementioned goods is included in the CY2020 Annual Procurement Plan (APP);

**WHEREAS**, the Approved Budget for the Contract under Small Value Procurement is P87,253.33;

**WHEREAS**, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for seven (7) calendar days and was sent to three (3) prospective suppliers, namely: VJ Graphic Arts, Inc., Calliope Printing Services and Offset Printing;

**WHEREAS**, in response to the said invitation, only one (1) prospective supplier submitted its quotation, to wit,

**WHEREAS**, after review and evaluation, BAC-TWG found VJ Graphic Arts, Inc. to be legally, financially, and technically capable to undertake the subject procurement, having submitted the Single Calculated and Responsive Quotation (SCRQ);

**WHEREAS**, considering that the amount involved in the subject procurement is **SEVENTY THREE THOUSAND SEVEN HUNDRED HUNDRED FIFTY PESOS (P73,750.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the

thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

**NOW, THEREFORE**, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of resort to alternative mode of procurement thru Small Value Procurement, and further recommend the award of contract to **VJ GRAPHIC ARTS, INC.** for the printing of VWC Therapeutic Journal in the amount of **SEVENTY THREE THOUSAND SEVEN HUNDRED FIFTY PESOS (P73,750.00)**.
