RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT WINSFORT CONSTRUCTION AND DEVELOPMENT FOR THE IMPROVEMENT OF THE DOJ ACADEMY AT JOSE ABAD SANTOS, CSEZ, PAMPANGA

WHEREAS, there is a need for the improvement of the DOJ Academy at Jose Abad Santos, CSEZ, Pampanga;

WHEREAS, the DOJ posted its Invitation to Bid for the aforesaid purchase in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 6 November 2020;

WHEREAS, the purchase of the said items is included in the CY 2020 Supplemental Annual Procurement Plan No. 1 (SAPP 1) with an allotted budget of Three Million Five Hundred Twenty Thousand Pesos (P3,520,000.00);

WHEREAS, the Approved Budget for the Contract is Three Million Five Hundred Eighteen Thousand Three Hundred Thirty Pesos & 32/100 (P3,518,330.32);

WHEREAS, in response to the said invitation, only one (1) prospective supplier submitted its bid in a public bidding (*via google meet*) held on 19 November 2020, 10:00 a.m., to wit,

WHEREAS, the aforesaid bids were referred to the DOJ Bids and Awards Committee-Technical Working Group (BAC-TWG) for evaluation and post-qualification, with the following findings:

WHEREAS, the DOJ BAC-TWG, after review and evaluation, finds that Winsfort Construction and Development submitted a single calculated and responsive bid and was found to be compliant and is legally, financially and technically capable to undertake the subject procurement;

NOW THEREFORE, after thorough deliberation, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to **Winsfort Construction and Development**, in the amount of **Three Million Five Hundred Nine Thousand Eight Hundred Eighty-Six Pesos & 92/100 (P3,509,886.92)**, for the improvement of the DOJ Academy at Jose Abad Santos, CSEZ, Pampanga, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
