WHEREAS, the Bids and Awards Committee (BAC) of the Regional Prosecution Office, Region XI resorted to Alternative Methods of Procurement in accordance with the provisions of Section 53.9 of the 2016 revised IRR of RA 9184 (Small Value Procurement) for the rental of studio facility to host the Online NPS XI Year-End Performance Assessment Conference 2020 on December 09, 2020;

WHEREAS, the Head of Office approved the rental of studio facility to host the Online NPS XI Year-End Performance Assessment Conference 2020 on December 09, 2020 from outside source;

**WHEREAS**, this office canvassed rental prices from at least three (3) service providers/firms who operated and owned a studio facility to host the **Online NPS XI Year-End Performance Assessment Conference 2020** on December 09, 2020, through this office's designated canvasser, and requested them to submit price quotation by accomplishing the official **Request for Quotation Form No. 2020-YEPA-02** dated December 03, 2020;

**WHEREAS**, the following are the service providers/firms, who operated and owned a studio that could facilitate the hosting of the **Online NPS XI Year-End Performance Assessment Conference 2020** on December 09, 2020, who submitted their respective accomplished original copy of the **Request for Quotation Form No. 2020-YEPA-02** dated December 03, 2020 for the concurrence of the BAC:

- 3. Infomedia Resource Management, Inc.

WHEREAS, deliberation of price quotations, for the rental of studio facility to host the Online NPS XI Year-End Performance Assessment Conference 2020 on December 09, 2020, was undertaken and abstract of quotation dated December 07, 2020 was prepared showing the lowest calculated responsive quotation;
