**RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF COMMON USE SUPPLIES & EQUIPMENT TO ADDRESS THE CURRENT STATE OF PUBLIC HEALTH EMERGENCY FOR NPS REGION V UNDER NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) SECTION 53.9 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184.**

**WHEREAS**, the Department approved the budget of Eight Hundred Twenty-Four Thousand Two Hundred Eighty Pesos Only (P 824,280.00) for the Procurement of Common Use Supplies & Equipment to Address the Current State Of Public Health Emergency For NPS Region V;

**WHEREAS**, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat posted the Request for Quotations (RFQ) in the Philippine Government Electronic Procurement System (PHILGEPS), DOJ website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

**WHEREAS**, the submission and opening of bids was scheduled on 21 December 2020;

**WHEREAS**, request for quotations from contractors/suppliers were obtained by the BAC Secretariat, attested by accomplished RFQs;


**WHEREAS**, per evaluation, bid of Bierich General Merchandise is found to be compliant with the specification and eligibility requirements;
