**RESOLUTION TO RECOMMEND TO THE HEAD OF THE PROCURING ENTITY
TO AWARD THE CONTRACT FOR THE PROCUREMENT OF
101 PIECES ACRYLIC BOARD, CLEAR, 3MM, 4 feet X 8 feet (COVID-19
RESPONSE ITEM) IN ACCORDANCE WITH THE PROVISION OF SECTION 53.9
OF THE 2016 REVISED IRR OF RA 9184
(SMALL VALUE PROCUREMENT)**

WHEREAS, the Bids and Awards Committee (BAC) of the Regional Prosecution Office, Region XI, resorted to Alternative Methods of Procurement in accordance with the provisions of Section 53.9 of 2016 revised IRR of RA 9184 (**Small Value Procurement**) for the procurement of **101 pieces acrylic board, clear, 3mm, 4 feet x 8 feet** (Covid-19 response item) not available in the Procurement Service Depot XI;

WHEREAS, the Head of Office approved the procurement of 101 pieces acrylic board, clear, 3mm, 4 feet x 8 feet, an item not available in the Procurement Service Depot XI, from outside source;

WHEREAS, this Office canvassed prices of the subject **acrylic boards**, through the designated canvasser, from at least three (3) suppliers to submit quotation by accomplishing the official Request for Quotation Form No. 2SEM-COVID-11 dated 11 December 2020;

WHEREAS, the notice of procurement of the subject **acrylic boards** was posted in the Philippine Government Electronic Procurement System (PhilGEPs) last 12 December 2020 with Reference No. 7352202;

WHEREAS, the following are the suppliers who submitted to this Office their respective original copies of accomplished Request for Quotations Form No. 2SEM-COVID-11, for the concurrence of the BAC;

1. Pagadian Glass & Aluminum Supply;
2. BLY Aluminum & Glass Supply;
3. Asia Glass Palace; and
4. DUBC Multi-Purpose Cooperative.

WHEREAS, deliberation of the price quotations for the **101 pieces acrylic board, clear, 3mm, 4 feet x 8 feet (Covid-19 response item)**, an item not available in the Procurement Service Depot XI, was undertaken and abstract of quotation was prepared showing the lowest calculated responsive quotation;


WHEREAS, the BAC, after due deliberation of the price quotations submitted by the aforementioned suppliers, recommended, as it is hereby recommended, to the Head of the Procuring Entity (HOPE) that the contract for the procurement of the **101 pieces acrylic board, clear, 3mm, 4 feet x 8 feet (Covid-19 response item)**, an item not available in the Procurement Service Depot XI, be awarded to **Pagadian Glass and Aluminum Supply** with business address at Sinsuat Avenue, Rosario Heights 7, Cotabato City, the **lowest calculated responsive quotation**, with a contract amount of **Two Hundred Forty Nine Thousand Four Hundred Seventy Pesos (P 249,470.00)**.

NOW THEREFORE, on the basis of the foregoing, it is **HEREBY RESOLVED** that the contract for the procurement of the **101 pieces acrylic board, clear, 3mm, 4 feet x 8 feet (Covid-19 response item)**, an item not available in the Procurement Service Depot XI, be awarded to **Pagadian Glass and Aluminum Supply** with business address at Sinsuat Avenue, Rosario Heights 7, Cotabato City, the **lowest calculated responsive quotation**, with a contract amount of **Two Hundred Forty Nine Thousand Four Hundred Seventy Pesos (P 249,470.00)**.
