RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO BLUE CHIP MARKETING FOR THE PURCHASE OF T-SHIRTS FOR THE CELEBRATION OF THE NATIONAL CHILDREN'S MONTH

WHEREAS, there is a need for the purchase of t-shirts for the celebration of the National Children's Month;

WHEREAS, the purchase of the aforementioned goods is included in the CY2020 Annual Procurement Plan (APP);

WHEREAS, the Approved Budget for the Contract under Small Value Procurement is P50,000.00;

WHEREAS, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for six (6) calendar days and was sent to three (3) prospective suppliers, namely: Blue Chip Marketing, Primewave Enterprises, Inc. and Inte Linea General Merchandise;

WHEREAS, in response to the said invitation, only one (1) prospective supplier submitted its quotation, to wit,

WHEREAS, after review and evaluation, BAC-TWG found Blue Chip Marketing to be legally, financially, and technically capable to undertake the subject procurement, having submitted the Single Calculated and Responsive Quotation (SCRQ);

WHEREAS, considering that the amount involved in the subject procurement is **FORTY-SEVEN THOUSAND TWO HUNDRED FIFTY PESOS (P47,250.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of resort to alternative mode of procurement thru Small Value Procurement, and further recommend the award of contract to **BLUE CHIP MARKETING** for the purchase of T-shirts for the celebration of the National Children's Month in the amount of **FORTY-SEVEN THOUSAND TWO HUNDRED FIFTY PESOS (P47,250.00)**.


