## **RESOLUTION**

### **RECOMMENDING THE AWARD OF CONTRACT TO COLUMBIA TECHNOLOGIES, INC. FOR THE PURCHASE OF 1 DOCUMENT CAMERA**

**WHEREAS**, there is a need for the purchase of one (1) document camera for the official use of the Bids and Awards Committee (BAC);

**WHEREAS**, the purchase of the said item is included in the CY2020 Supplemental Annual Procurement Plan No. 9 (SAPP 9), with an allotted budget of Thirty-Three Thousand Pesos (P33,000.00);

**WHEREAS**, the Procurement Management Division (PMD) sent its request for quotation to three (3) prospective suppliers;

**WHEREAS**, in response to the said request, three (3) prospective suppliers submitted their quotations, to wit,

**WHEREAS**, the DOJ BAC-TWG, after review and evaluation, finds that Columbia Technologies, Inc. submitted the Lowest Calculated and Responsive Quotation (LCRQ) and was found to be compliant and is legally, financially and technically capable to undertake the subject procurement;

**WHEREAS**, considering that the amount involved in the subject procurement is Thirty-One Thousand One Hundred Seventy Pesos (P31,170.00), an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations.

**NOW THEREFORE**, after thorough deliberation, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of the use of an alternative mode of procurement, and further recommend the award of contract to Columbia Technologies, Inc., in the amount of Thirty-One Thousand One Hundred Seventy Pesos (P31,170.00), for the purchase of one (1) unit document camera, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
