RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO THE PHILIPPINE INTERNATIONAL CONVENTION CENTER FOR THE CONDUCT OF THE 13TH INTER-AGENCY COMMITTEE OF THE ADMINISTRATIVE ORDER NO. 35 – INTER-AGENCY COMMITTEE TO BE HELD ON 10 MARCH 2020

WHEREAS, there is a need for a venue for the conduct of the 13th Inter-Agency Committee Meeting of the Administrative Order No. 35 (AO 35) – Inter-Agency Committee (IAC) to be held on 10 March 2020;

WHEREAS, the procurement for the lease of venue for the said event is included in the CY 2020 Annual Procurement Plan (APP), with an allotted budget of Three Hundred Thousand Pesos (P300,000.00);

WHEREAS, pursuant to the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184, it is the policy of the government to give preference to publicly-owned real property or venue over privately-owned real property or venue, insofar as the lease of real property or venue for official use is concerned¹;

WHEREAS, the Philippine International Convention Center (PICC) is a government-owned institution, constructed pursuant to Presidential Decree No. 520 (s. 1974), as amended, as an international conference center suitable for the holding of international conferences, meetings, and similar undertakings;

WHEREAS, based on the aggregate charges sheet submitted by PICC, the total cost of lease of venue for the said activity, including the use of meeting room, meals and other requirements, is Two Hundred Four Thousand Pesos (P204,000.00);

NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to PICC, as the venue for the
