**BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO
COPYLANDIA OFFICE SYSTEMS CORPORATION FOR THE
PURCHASE OF TONERS FOR DEVELOP PHOTOCOPIER**

WHEREAS, there is an approved Purchase Request with PR No. 2020-06-0014 dated June 3, 2020 with an approved budget for the contract of Seven Thousand Two Hundred Pesos (P7, 200.00) for the purchase of toners for Develop Photocopier for the Regional Prosecution Office, Provincial Prosecution and City Prosecution offices of Region I;

WHEREAS, the procurement of the aforementioned items is included in the Annual Procurement Plan (APP) for CY 2020 which shall be undertaken through Direct Contracting in accordance with Section 50 of the 2019 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184;

WHEREAS, per Letter of Confirmation dated April 1, 2020, Konica Minolta Business Solutions Asia Pte Ltd had appointed Copylandia Office Systems Corporation as their exclusive distributor for the sale and/or rental of "DEVELOP" branded black and white, and color electrostatic plain paper copying/printing machines and their consumables and spare parts in Philippines;

WHEREAS, on June 4, 2020, the BAC thru its Secretariat, sent the Request for Quotation only to Copylandia Office Systems Corporation;

WHEREAS, before the lapse of the deadline on June 8, 2020 at 2:00 p.m., Copylandia Office Systems Corporation submitted its quotation along with their PhilGEPS Registration Number and Mayor's/ Business Permit;

WHEREAS, upon careful review of the quotation and documents submitted by the supplier, the BAC determined Copylandia Office Systems Corporation as compliant with the legal, technical, and financial requirements of the project;

NOW, THEREFORE, in view of the foregoing, we, the Bids and Awards Committee hereby resolve to recommend to the Head of the Procuring Entity for his consideration and approval the award of contract to Copylandia Office Systems Corporation for the purchase of toners of Develop Photocopier in the amount of Seven Thousand Twenty Five Pesos (P 7, 025.00).


