## RESOLUTION

**A RESOLUTION RECOMMENDING THE APPROVAL OF PURCHASE ORDER NO. 05-2020 FOR THE PURCHASE OF FUJIXEROX S2320 TONER CARTRIDGE FOR REGIONAL, PROVINCIAL AND CITY PROSECUTION OFFICES, REGION VI.**

**WHEREAS**, there is an urgent need to purchase of Fuji Xerox S2320 Toner Cartridge for the use of Regional, Provincial and City Prosecution Offices in Region VI;

**WHEREAS**, the procurement of the of Fuji Xerox S2320 Toner Cartridge included in the approved FY 2020 Annual Procurement Plan (APP) with allotted budget **Three Hundred Ten Thousand Seven Hundred Fifty Pesos (P310,750.00)**;

**WHEREAS**, the Regional Prosecution Offices indicated that the consumables for Copier Model: Fuji Xerox S2320 (10 units) are exclusively distributed by Photo Pro Trading and General Merchandise Co.;

**WHEREAS**, the mode of procurement to be resorted is through direct contracting with an exclusive distributor or manufacturer, which does not have sub-dealers selling at low prices, and for which no suitable substitute can be obtained which is more advantageous to the government;

**WHEREAS**, pursuant to Department Circular 011 dated 06 February 2012, with subject: Amended Policy on Review and Approval of Job Orders and Contracts in the Department of Justice, for purposes of expediting the process of all matters on procurement, each Purchase Order/Job Order/contract amounting to **THIRTY TWO THOUSAND FIVE HUNDRED PESOS (Php 32,500.00)** that is resorted through an alternative mode of procurement as indicated in the Department APP shall aside from establishing the legal, technical and financial capability of the concerned supplier/contractor, obtain approval from the DOJ BAC;
