RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO ZURBANO PUBLISHING & PRINTING CORP. FOR THE PRINTING AND PUBLICATION OF VARIOUS INFORMATION, EDUCATION AND COMMUNICATION MATERIALS FOR THE INTER-AGENCY COUNCIL AGAINST TRAFFICKING

WHEREAS, there is a need for the printing & publication of various information, education and communication materials of the Inter-Agency Council Against Trafficking (IACAT);

WHEREAS, the DOJ posted its Invitation to Bid for the aforesaid purchase in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 25 November 2020;

WHEREAS, the purchase of the said items is included in the CY 2020 Annual Procurement Plan with an allotted budget of One Million Pesos (P1,000,000.00);

WHEREAS, the Approved Budget for the Contract is Nine Hundred Forty-Three Thousand Thirty-Three Pesos (P943,033.00);

WHEREAS, in response to the said invitation, four (4) prospective suppliers submitted their bids in a public bidding (*via google meet*) held on 16 December 2020, 10:00 a.m., to wit,

No. 9184 and its 2016 Revised Implementing Rules and Regulations.
