## **RESOLUTION**

### **A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO ILOILO YCA DALE TRADING FOR THE SUPPLY AND DELIVERY OF TWENTY (23)PCS. INFRARED THERMOMETER GUN FOR NPS-REGION VI**

**WHEREAS**, President Rodrigo Roa Duterte declared a State of Public Health Emergency throughout the Philippines due to the Corona Virus Disease(COVID-19) under Proclamation No. 922 dated March 8, 2020;

**WHEREAS**, included in the CY 2020 Supplemental Annual Procurement Plan No. 2 is the purchase of Common-Use Supplies and Equipment to address the current State of Public Health Emergency;

**WHEREAS**, the NPS-Region VI Office, through its Bids and Awards Committee (BAC), intends to procure the 23 pcs Infrared Thermometer Gun for the official use of NPS-Region VI, in line with the Memorandum dated March 13, 2020 issued by Usec. Juliana G. Sunga;

**WHEREAS**, the BAC was authorized to resort Alternative Method of Procurement in accordance with the provision of Sec. 53.2 of the Revised Implementing Rules and Regulations of RA 9184 (Emergency Cases) as per approved authority;

**WHEREAS**, the above-mentioned project has an approved budget for contract of One Hundred Thousand Pesos (P 100,000.00)

**WHEREAS**, the Robenj Biomedical Equipment Services and Tech. Corp. was the lowest bidder. However, due to the exigency of the procured items and the accessibility of the supplier, the BAC opted to engage a local supplier;

**WHEREAS**, the BAC directly negotiated to a legally, technically and financially capable supplier namely, Iloilo Yca Dale Trading;

**WHEREAS**, the Iloilo Yca dale Trading was found to be responsive and compliant with the requirements set by the BAC;

**NOW, THEREFORE**, on the basis of the foregoing, We, the members of the Bids and Awards Committee, hereby resolve as it is hereby RESOLVED to recommend the award and approval of the Purchase Order No. 01-2020 in the amount of Seventy-Seven Thousand Fifty Pesos (P77,050.00) for the supply and delivery of Twenty (23) pcs Infrared Thermometer Gun for NPS-Region VI in favor of Iloilo Yca Dale Trading.
