BAC RESOLUTION DECLARING THE BIDDER WITH LOWEST CALCULATED RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT FOR LEASE OF VENUE WITH ACCOMMODATION AND MEALS FOR THE SEMINAR ON GENDER AND DEVELOPMENT (GAD)/EMPLOYMENT EMPOWERMENT AND THE 10TH REGIONAL CONVENTION OF REGION V (NEGOTIATED PROCUREMENT: LEASE OF REAL PROPERTY AND VENUE) UNDER SECTION 53.10 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184

WHEREAS, the Department approved the Annual Procurement Plan, included in the APP is the Seminar on Gender and Development/Employment Empowerment and 10th Regional Convention requiring the Lease of Venue with Meals, to be undertaken through Section 53.10 (Lease of Venue) of the Revised Implementing Rules and Regulations of Republic Act 9184;

WHEREAS, the procurement of Lease of Venue, including meals for the Seminar on Gender and Development/Employment Empowerment and 10th Regional Convention of Region V has an Approved Budget for the Contract (ABC) of Seven Hundred Twenty Nine Thousand Two Hundred Pesos (Php729,200.00) will be conducted within Camarines Sur on February 26-28, 2020;

WHEREAS, pursuant to DOJ Department Circular No. 036 dated September 5, 2016, Trainings, Workshops and Conferences shall be held in the facilities of the Department or other government offices;

WHEREAS, on January 21, 2020, letter-request was sent to the City Mayor of Naga City;

WHEREAS, on February 6, 2020, reply from the City Mayor of Naga was received which states that there is no available LGU facility to accommodate the participants, thus the Bids and Awards Committee resorted to canvass from privately-owned real property/hotel was made;

WHEREAS, on February 11, 2020, the RPO BAC Secretariat thru the City Prosecution Office of Naga City, initiated the procurement activity by sending Request for Quotation (RFQs) to three prospective lessors, viz: (1) Peñafrancia Resort, Inc. (2) Robiedo, Inc. (3) Avenue Plaza Hotel;

WHEREAS, on February 14, 2020, the RPO BAC Secretariat received the quotations from the following:

WHEREAS, upon careful review and evaluation of the documentary, technical and financial requirements submitted by the Bidders, the BAC determined that the Peñafrancia Resort, Inc. qualified by giving the lowest bid, meeting the Approved Budget for the Contract (ABC) and complied with all the eligibility, technical and financial requirements of the project;


WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;


NOW THEREFORE, for and in consideration of the foregoing, We, the members of the RPO V-Bids and Awards Committee, hereby **RESOLVE**, as it is hereby Resolved that the following action be undertaken relative to the Lease of Venue with Accommodation and Meals:

- 1) To declare **PEÑAFRANCIA RESORT, INC.** as the bidder with Lowest Calculated Responsive Bid for the abovementioned project and;
- 2) To recommend to the Regional Prosecutor the approval of the **AWARD OF CONTRACT** for the Lease of Venue with Accommodation and Meals for the Seminar on Gender and Development (GAD)/Employment Empowerment and 10th Regional Convention of Region V with contract price of Seven Hundred Twenty Eight Thousand Nine Hundred Pesos (PhP728,900.00) inclusive of appropriate taxes and fees.
