**BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO
PHILCOPY CORPORATION FOR THE PURCHASE OF KYOCERA
PHOTOCOPIER CONSUMABLES**

WHEREAS, there is an approved Purchase Request with PR No. 2020-06-0016 dated June 3, 2020 with an approved budget for the contract of One Hundred Thousand Five Hundred Pesos (P100, 500.00) for the purchase of Kyocera Photocopier consumables for the Regional Prosecution Office, Provincial Prosecution and City Prosecution offices of Region I;

WHEREAS, the procurement of the aforementioned items is included in the Annual Procurement Plan (APP) for CY 2020 which shall be undertaken through Direct Contracting in accordance with Section 50 of the 2019 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184;

WHEREAS, per Sworn Certificate of Guarantee Exclusive Distributorship Agreement dated May 6, 2020, Philcopy Corporation was appointed by Kyocera Document Solutions Asia Limited as an exclusive distributor in marketing and servicing Kyocera Document Solutions brand copiers, laser printers and multi-functional peripheral, software solutions, including related consumables and spare parts in the Philippines;

WHEREAS, on June 5, 2020, the BAC thru its Secretariat, sent the Request for Quotation only to Philcopy Corporation;

WHEREAS, before the lapse of the deadline on June 8, 2020 at 2:00 p.m., Philcopy Corporation submitted its quotation along with their PhilGEPS Registration Number and Mayor's/ Business Permit;

WHEREAS, upon careful review of the quotation and documents submitted by the supplier, the BAC determined Philcopy Corporation as compliant with the legal, technical, and financial requirements of the project;

NOW, THEREFORE, in view of the foregoing, we, the Bids and Awards Committee hereby resolve to recommend to the Head of the Procuring Entity for his consideration and approval the award of contract to Philcopy Corporation for the purchase of Kyocera Photocopier Consumables in the amount of Ninety- Six Thousand One Hundred Pesos (P 96, 100.00).


