RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF VARIOUS OFFICE SUPPLIES AND MATERIALS THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) UNDER SECTION 53.9 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184

**WHEREAS**, the Department approved the budget of One Hundred Fourteen Thousand Nine Hundred Eighty Eight Pesos and Ten Centavos (P114,988.10) for the Procurement of various office supplies and materials for NPS Region V;

**WHEREAS**, Regional Prosecution Office V through the Bids and Awards Committee (BAC), posted the Request for Quotation (RFQ) for the above-mentioned project through posting in the Philippine Government Electronic Procurement System (PHILGEPS), DOJ website and in conspicuous place in the premises of Regional Prosecution Office V;

**WHEREAS**, on September 8, 2020, the RPO V- Bids and Awards Committee Secretariat sent Request for Quotations (RFQs) for the procurement of the above mentioned project to the following suppliers, viz;

1. LPS Plus
2. New Silahis Office Supplies Trading
3. Legazpi Jebson Trading
4. Lucky Educational Supply

**WHEREAS**, the submission and opening of bids was scheduled on September 14, 2020;

**WHEREAS**, on different dates prior to the deadline of submission of price quotations, quotations from four (4) suppliers were obtained by the BAC Secretariat, attested by accomplished Request for Price Quotation (RFQ);

**WHEREAS**, in the course of the evaluation of the bids by the BAC the following are the result:

Supplier	Bid Amount	Remarks
a. LPS Plus	No total amount indicated	INELIGIBLE, due to incomplete entry in the RFQ, non-compliant with the eligibility requirements
b. New Silahis Office Supplies Trading	No total amount indicated	INELIGIBLE, due to incomplete entry in the RFQ, non-compliant with the eligibility requirements
c. Legazpi Jebson Trading	Php65,967.50	ELIGIBLE, compliant with the specifications and eligibility requirements
d. Lucky Educational Supply	Php62,066.36	INELIGIBLE, due to incomplete quotation and eligibility requirements (no SEC/DTI registration)


**WHEREAS**, per evaluation, the proposal of Legazpi Jebson Trading found to be compliant with the specifications and the details of the duly accomplished RFQ together with the eligibility requirements;



**NOW THEREFORE**, for and in consideration of the foregoing, We, the members of the RPO V-BAC, hereby **RECOMMEND** to the Regional Prosecutor, the following:

**1. AWARD OF CONTRACT** via Small Value Procurement to Legazpi Jebson Trading for the procurement of various office supplies and materials, in the amount of Sixty Five Thousand Nine Hundred Sixty Seven Pesos and Fifty Centavos (P65,967.50) inclusive of appropriate taxes and fees;


