RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO WHITELIGHT CREATIVE MANAGEMENT, INC. FOR THE PRODUCTION OF VIDEO FOR THE GLOBAL VIRTUAL SUMMIT OF THE INTER-AGENCY COUNCIL AGAINST TRAFFICKING

WHEREAS, there is a need for the production of video for the global virtual summit of the Inter-Agency Council Against Trafficking (IACAT);

WHEREAS, the purchase of the aforementioned goods is included in the CY2020 Annual Procurement Plan (APP);

WHEREAS, the Approved Budget for the Contract under Small Value Procurement is P700,000.00;

WHEREAS, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for six (6) calendar days and was sent to three (3) prospective suppliers, namely: Team on Ground, Inc., Whitelight Creative Management, Inc. and CMC Production Consulting Company, Inc.;

WHEREAS, in response to the said invitation, only one (1) prospective supplier submitted its quotation, to wit,

WHEREAS, after review and evaluation, BAC-TWG found Whitelight Creative Management, Inc. to be legally, financially, and technically capable to undertake the subject procurement, and thus, considered to have submitted the Single Calculated and Responsive Quotation (SCRQ);

WHEREAS, considering that the amount involved in the subject procurement is **SEVEN HUNDRED THOUSAND PESOS (P700,000.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of resort to alternative mode of procurement thru Small Value Procurement, and further recommend the award of contract to **WHITELIGHT CREATIVE MANAGEMENT, INC.** in the amount of **SEVEN HUNDRED THOUSAND PESOS (P700,000.00)** for the production of video for the global virtual summit of the Inter-Agency Council Against Trafficking..
