**RECOMMENDING AWARD OF CONTRACT TO PC4ME ONE STOP
COMPUTER CORP FOR THE PROCUREMENT OF 50 UNITS OF INKJET
PRINTER, 3-IN-1 FUNCTION (LOT 1) AND 32 UNITS OF INKJET PRINTER,
4-IN-1 FUNCTION (LOT 2)**

WHEREAS, the Regional Prosecution Office 1, through the Bids and Awards Committee, posted the Request for Quotation (RFQ) for the Purchase of 50 units of Inkjet Printer, 3-in 1 function (LOT 1) and 32 units of Inkjet Printer, 4-in 1 function (LOT 2) with a total Approved Budget for the Contract of Nine Hundred Ninety-Eight Thousand Nine Hundred Sixty- Eight Pesos (P 998, 968.00) in the PhilGEPS and in a conspicuous place in the premises of the City of San Fernando, La Union and the Justice Hall, Sevilla, San Fernando City, La Union continuously from November 5-10, 2020;

WHEREAS, the purchase of the aforementioned items is included in the CY 2020 Supplemental Annual Procurement Plan No. 15 which will be procured pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, the Regional Prosecution Office 1, through the Bids and Awards Committee, also sent the RFQ to three (3) prospective suppliers, namely: (1) PC4ME One-Stop Computer Corp.; (2) Insystech; and (3) Bitz Computer Shop;

WHEREAS, before the lapse of the deadline for submission of quotation at 2:00 p.m. on November 10, 2020, only PC4ME One-Stop Computer Corp. submitted its bid for Lot 1 and 2;

WHEREAS, upon careful review and evaluation of the legal and technical documents submitted by the lone bidder, it was found to be compliant with the requirements set by the BAC. Likewise, the BAC also determined the financial proposal submitted by PC4ME One-Stop Computer Corp in the amount of Five Hundred Eight Thousand Seven Hundred Fifty Pesos (P 508, 750.00) for Lot 1 and Four Hundred Thirty Eight Thousand Two Hundred Forty Pesos (P 438, 240.00) as the single calculated and responsive bid, and, thus, being recommended for consideration of award of contract;

NOW, THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

1. To declare PC4ME One-Stop Computer Corp as the Single Calculated and Responsive Bidder for Lot 1 and 2; and
2. To recommend to the Head of the Procuring Entity the award of contract for the procurement of 50 units of Inkjet Printer, 3-in 1 function (LOT 1) and 32 units of Inkjet Printer, 4-in 1 function (LOT 2) with a total contact price of Nine Hundred Forty Six Thousand Nine Hundred Ninety Pesos (P 946, 990.00) in favor of PC4ME One-Stop Computer Corp.


