RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO THE NATIONAL PRINTING OFFICE FOR THE PURCHASE OF PERSONALIZED ACCOUNTABLE NO. 51 (OFFICIAL RECEIPTS), FOR THE OFFICIAL USE OF THE NATIONAL PROSECUTION SERVICE AND BOARD OF CLAIMS THROUGH NEGOTIATED PROCUREMENT (AGENCY-TO-AGENCY)

WHEREAS, there is a need to purchase Personalized Accountable Form No. 51 (Official Receipts) for the official use of the National Prosecution Service (NPS) and the Board of Claims (BOC);

WHEREAS, the purchase of the aforementioned procurement is included in the approved CY 2020 Annual Procurement Plan (APP), with a total allotted budget of Two Million Three Hundred Fifteen Thousand Pesos (P2,315,000.00);

WHEREAS, the procurement of the printing services of National Printing Office (NPO) mentioned above falls within the negotiated procurement of Agency-to-Agency, an alternative mode of procurement under R.A. No. 9184 and its Revised Implementing Rules and Regulations;

WHEREAS, based on the official price list and production cost estimate submitted by Francisco V. Vales, Jr., Director IV, NPO, said procurement has a total amount of Two Million Three Hundred Fifteen Thousand Pesos (P2,315,000.00);

NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of Agency-to-Agency as an alternative mode of procurement, and the award of contract to NPO for the purchase of Personalized Accountable Form No. 51 (Official Receipts) for the official use of NPS and BOC in the amount of Two Million Three Hundred Fifteen Thousand Pesos (P2,315,000.00)
