RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO RGSA CARPETS AND INTERIOR PRODUCTS, INC. FOR THE PURCHASE OF ROLL UP BLINDS AND FOLDING DOORS

WHEREAS, there is a need for the purchase of roll up blinds and folding doors to be installed at various DOJ main offices;

WHEREAS, the DOJ posted its Invitation to Bid for the aforesaid purchase in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 5 August 2020;

WHEREAS, the purchase of the said items is included in the CY 2020 Supplemental Annual Procurement Plan No. 1 & 4 (SAPP 1 & 4) with a total allotted budget of Nine Hundred Nine Thousand Three Hundred Eighty-Eight Pesos & 50/100 (P909,388.50);

WHEREAS, the Approved Budget for the Contract is Nine Hundred Nine Thousand Three Hundred Eighty-Eight Pesos & 50/100 (P909,388.50);

WHEREAS, in response to the said invitation, six (6) prospective suppliers submitted their bids in a public bidding (*via google meet*) held on 17 August 2020, 2:00 p.m., to wit,

WHEREAS, the aforesaid bids were referred to the DOJ Bids and Awards Committee-Technical Working Group (BAC-TWG) for evaluation and post-qualification, with the following findings:

NOW THEREFORE, after thorough deliberation, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to RGSA Corporate & Interior Products, in the amount of Two Hundred

Ninety-Eight Thousand Eight Hundred Eighty-Eight Pesos & 88/100 (P298,888.88), for the purchase of roll up blinds and folding doors to be installed at various DOJ main offices, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
