**RECOMMENDING THE AWARD OF CONTRACT TO Z.C. PAPERLINE &
COMPUTER STATIONER FOR THE PURCHASE OF VARIOUS OFFICE
FURNITURES FOR REGIONAL PROSECUTION OFFICE IX**

WHEREAS, there is an urgent need to purchase various furnitures for the Regional Prosecution Office, Region IX;

WHEREAS, the Regional Prosecution Office IX, through the Bids and Awards Committee, posted its Request for Quotation for the subject items in the PHILGEPS and conspicuous place in the Hall of Justice, Sta. Barbara, Zamboanga City;

WHEREAS, the purchase of the aforementioned goods is included in the Annual Procurement Plan (APP) for CY 2019 of the National Prosecution Service, Region IX, with an allotted budget of P259,400.00;

WHEREAS, in response to the said request for quotation, three (3) prospective suppliers submitted their quotation;

WHEREAS, upon careful evaluation the BAC, found the offer of Z.C. Paperline & Computer Stationers as the lowest calculated, eligible and responsive quotation;

WHEREAS, considering that the amount involved in the subject procurement is TWO HUNDRED FIFTY NINE THOUSAND ONE HUNDRED TWENTY FOUR (P259,124.00) an alternative mode of procurement is allowed provided, that the amount shall not exceed the thresholds prescribed in the Annex "H" of the 2016 Revised Implementing Rules and Regulations of R.A. 9184

NOW, THEREFORE, We, the Bids and Awards Committee hereby RESOLVE, as it si RESOLVED:

1. To recommend that the procurement of various furniture for the Regional Prosecution Office, Region IX be done though small Value Procurement as an alternative mode of procurement;

2. To award the contract to Z.C. Paperline & Computer Stationers for the purchase of various furniture for the Regional Prosecution Office, Region IX in the amount of Two Hundred Fifty Nine Thousand One Hundred Twenty Four Pesos (P259,124.00)






