RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO ARISTOCRAT RESTAURANT FOR THE PURCHASE OF PACKED LUNCH FOR THE 123RD FOUNDING ANNIVERSARY OF THE DEPARTMENT OF JUSTICE ON 25 SEPTEMBER 2020

WHEREAS, there is a need for the purchase of packed lunch for the 123rd Founding Anniversary of the Department of Justice on 25 September 2020;

WHEREAS, the aforementioned procurement is included in the Approved Annual Procurement Plan (APP) for CY 2020;

WHEREAS, the Approved Budget for the Contract under small value procurement is One Hundred Forty Thousand Pesos (P140,000.00);

WHEREAS, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject procurement in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for four (4) calendar days, and was sent to three (3) prospective suppliers, namely: The Aristocrat Restaurant, Max's Kitchen, Inc., and Savory Fastfood Incorporated;

WHEREAS, in response to the said invitation, three (3) prospective suppliers submitted their quotations, to wit:

WHEREAS, after review and evaluation, the BAC-Technical Working Group found The Aristocrat Restaurant to have submitted a Single Calculated and Responsive Quotation (SCRQ), having passed and complied with the legal, financial, and technical requirements to undertake the subject procurement;

WHEREAS, considering that the amount involved in the subject procurement is **ONE HUNDRED THIRTY THOUSAND PESOS (P130,000.00)**, an alternative mode of procurement is allowed in Republic Act No. 9184 or the GPRA, as the amount does not exceed the threshold prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of Small Value Procurement as an alternative mode of procurement, and the award of contract to **The Aristocrat Restaurant** in the amount of **ONE HUNDRED THIRTY THOUSAND PESOS (P130,000.00)** for the purchase of packed lunch for the 123rd Founding Anniversary of the Department of Justice to be held on 25 September 2020.
