RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO EQUILAST, INC. FOR THE PURCHASE OF TIRES FOR VARIOUS OFFICIAL VEHICLES OF THE DEPARTMENT OF JUSTICE

WHEREAS, there is a need for the purchase of tires for various official vehicles of the Department of Justice;

WHEREAS, the purchase of the aforementioned goods is included in the CY2020 Annual Procurement Plan;

WHEREAS, the Approved Budget for the Contract under Small Value Procurement is P134,150.00

WHEREAS, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for four (4) calendar days and was sent to three (3) prospective suppliers, namely: Achievers Sales Corporation, Megabatz Trading and Incredible Comet Tires and Auto Services;

WHEREAS, in response to the said invitation, four (4) prospective suppliers submitted their quotations, to wit,

WHEREAS, after review and evaluation, the DOJ BAC-TWG found that EQUILAST INC. is legally, financially, and technically capable to undertake the subject procurement, and for having submitted the Lowest Calculated and Responsive Quotation (LCRQ);

WHEREAS, considering that the amount involved in the subject procurement is **EIGHTY SEVEN THOUSAND NINE HUNDRED FORTY PESOS (P87,940.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of Small Value Procurement as an alternative mode of procurement, and the award of contract to **EQUILAST INC.** for the purchase of tires for various official vehicles of the Department of Justice in the amount of **EIGHTY SEVEN THOUSAND NINE HUNDRED FORTY PESOS (P87,940.00)**.


