RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO REMAX INTERNATIONAL, INC. FOR THE PURCHASE OF 10 UNITS HIGH-END LAPTOP AND 104 UNITS REGULAR LAPTOP

WHEREAS, there is a need for the purchase of 10 units of high-end laptop and 104 units of regular laptop;

WHEREAS, the DOJ posted its Invitation to Bid for the aforesaid purchase in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 4 August 2020;

WHEREAS, the purchase of the said items is included in the CY 2020 Supplemental Annual Procurement Plan No. 4 (SAPP 4) with an allotted budget of Six Million Two Hundred Forty-Eight Thousand Pesos (P6,248,000.00);

WHEREAS, the Approved Budget for the Contract is Six Million Two Hundred Forty-Eight Thousand Pesos (P6,248,000.00);

WHEREAS, in response to the said invitation, two (2) prospective suppliers submitted their bids in a public bidding (*via google*) held on 26 August 2020, 2:00 p.m., to wit,



WHEREAS, after review and evaluation, the BAC-TWG finds that Remax International, Inc. submitted the lowest calculated bid and was found to be compliant and is legally, financially and technically capable to undertake the subject procurement;

NOW THEREFORE, after thorough deliberation, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to **REMAX INTERNATIONAL, INC.**, in the amount of **Five Million Nine Hundred Sixty-Three Thousand Seven Hundred Four Pesos (P5,963,704.00)**, for the purchase of 10 units of high-end laptop and 104 units of regular laptop, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
