RESOLUTION No. 2020- 10- 0014

**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO
DACANAY'S PRINTING SHOP AND GENERAL MERCHANDISE FOR THE
SUPPLY AND DELIVERY OF FACE MASKS (REUSABLE) FOR NPS-
REGION I**

WHEREAS, Proclamation No. 929 s. 2020, was promulgated on March 16, 2020 declaring a State of Calamity throughout the Philippines for a period of six (6) months due to Corona Virus Disease (COVID- 19);

WHEREAS, the number of COVID- 19 positive cases and deaths continue to rise despite efforts and interventions to contain the same;

WHEREAS, President Duterte signed Proclamation No. 1021 dated September 16, 2020 extending the State of Calamity throughout the Philippines for a period of one (1) year effective September 13, 2020 to September 12, 2021;

WHEREAS, the Regional Prosecution Office 1, through the Bids and Awards Committee (BAC), intends to procure face masks (reusable) which are essential to comply with the minimum health standards for COVID-19 mitigation;

WHEREAS, the purchase of face masks (reusable) is included in the CY 2020 Supplemental Annual Procurement Plan No. 4 with an allotted budget amounting to Eighty-Six Thousand Pesos (Php 86,000.00);

WHEREAS, the subject procurement shall be undertaken in accordance with the provisions of Sec. 53.2 of the Revised Implementing Rules and Regulations of RA 9184 (Emergency Cases);

WHEREAS, the BAC directly negotiated with a legally, technically and financially capable supplier namely, Dacanay's Printing Shop and General Merchandise;


NOW, THEREFORE, on the basis of the foregoing, We, the members of the BIDS and Awards Committee, hereby resolve as it is hereby **RESOLVED** to recommend the award and approval of the Purchase Order No. 2020- 10- 0017 in the amount of Eighty- Five Thousand Nine Hundred Eighty Pesos (Php 85, 980.00) for the supply and delivery of face masks (reusable) for NPS- Region 1 in favor of Dacanay's Printing Shop and General Merchandise.
