RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO IMAX TECHNOLOGIES INC. FOR THE SUPPLY AND DELIVERY OF FIFTY-SIX (56) UNITS WEB CAMERA WITH BUILT-IN MICROPHONE AND FIFTY-SIX (56) UNITS SPEAKER SYSTEM

WHEREAS, there is a need for the supply and delivery of fifty-six (56) units web camera with built-in microphone and fifty-six (56) units speaker system;

WHEREAS, the purchase of the aforementioned goods is included in the CY2020 Supplemental Annual Procurement Plan No. 4 (SAPP No. 4);

WHEREAS, the Approved Budget for the Contract under Small Value Procurement is P282,352.00;

WHEREAS, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

WHEREAS, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for six (6) calendar days and was sent to three (3) prospective suppliers, namely: Pronet Systems Integrated Network Solution Inc., Infoworx Inc. and Bridgecom Enterprises;

WHEREAS, in response to the invitation, two (2) prospective suppliers submitted their quotations, to wit,

WHEREAS, after review and evaluation, BAC-TWG found Imax Technologies Inc. to have submitted the Lowest Calculated and Responsive Quotation (SCRQ in the amount of **ONE HUNDRED SEVENTY THOUSAND**

FOUR HUNDRED EIGHT PESOS (P170,408.00), having passed and complied with all the legal, financial, and technical requirements to undertake the subject procurement;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of Small Value Procurement as an alternative mode of procurement, and the award of contract to **Imax Technologies Inc.** for the supply and delivery of fifty-six (56) units web camera with built-in microphone and fifty-six (56) units speaker system in the amount of **ONE HUNDRED SEVENTY THOUSAND FOUR HUNDRED EIGHT PESOS (P170,408.00)**.
