RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO VIGILANT INVESTIGATIVE & SECURITY AGENCY, INC. FOR THE PROCUREMENT OF SECURITY SERVICES FOR FY 2021

WHEREAS, there is a need for the procurement of security services for FY 2021;

WHEREAS, the DOJ posted its Invitation to Bid for the aforesaid purchase in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 11 November 2020;

WHEREAS, the purchase of the said items is included in the CY 2021 Indicative Annual Procurement Plan with a total allotted budget of Ten Million One Hundred Forty-Five Thousand Pesos (P10,145,000.00);

WHEREAS, the Approved Budget for the Contract is Ten Million Five Thousand Nine Hundred Sixty-Three Pesos & 12/100 (P10,005,963.12);

WHEREAS, in response to the said invitation, only one (1) prospective supplier submitted its bid in a public bidding (*via google meet*) held on 1 December 2020, 10:00 a.m., to wit,

WHEREAS, the aforesaid bids were referred to the DOJ Bids and Awards Committee-Technical Working Group (BAC-TWG) for evaluation and post-qualification, with the following findings:
