RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO E-COPY CORPORATION FOR THE PURCHASE OF VARIOUS CONSUMABLES FOR COPIER MODEL SHARP AR 6031N

WHEREAS, there is an urgent need for the purchase of various consumables for Copier Model Sharp AR 6031N for the use of the Technical Staff of the Department of Justice (DOJ);

WHEREAS, the procurement of the said consumable items is included in the CY 2020 Annual Procurement Plan (APP) with an allotted budget of Fifty-Nine Thousand Five Hundred Thirty-Seven Pesos (P59,537.00);

WHEREAS, the Procurement Management Division indicated that the various consumables for Copier Model Sharp AR 6031N are exclusively distributed by E-Copy Corporation as certified by Mr. Yoshitaka Honda, E-Copy Corporation BU Vice President, Office Solution Business Unit;

WHEREAS, in the price quotation dated 13 February 2020 submitted by E-Copy Corporation to the DOJ, the total cost for the purchase of the said consumables is Twenty-Eight Thousand Forty-Seven Pesos (P28,047.00);

WHEREAS, direct contracting¹ may be resorted to when the items to be procured are sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GOP;

NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to E-Copy Corporation, in the amount of Twenty-Eight Thousand Forty-Seven Pesos (P28,047.00), for the purchase of various consumables for Copier Model Sharp AR 6031N, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
