RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO TRENDS & TECHNOLOGIES, INC. FOR THE PROCUREMENT OF RENEWAL OF FIREWALL LICENSE FOR NPS-NCR OFFICES

WHEREAS, there is a need for the procurement of renewal of Firewall License for NPS-NCR offices;

WHEREAS, the DOJ posted its Invitation to Bid for the aforesaid purchase in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 21 November 2020;

WHEREAS, the purchase of the said items is included in the CY 2021 Indicative Annual Procurement Plan with a total allotted budget of Four Million Five Hundred Thousand Pesos (P4,500,000.00);

WHEREAS, in response to the said invitation, only one (1) prospective supplier submitted its bid in a public bidding (*via google meet*) held on 15 December 2020, 10:30 a.m., to wit,
