RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT AND DELIVERY OF FORTY TWO (42) UNITS JUNIOR EXECUTIVE CHAIR WITH ARM REST THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) UNDER SECTION 53.9 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184

WHEREAS, the Department approved the budget of One Hundred Sixty Three Thousand Five Hundred Ninety Pesos (P163,590.00) for the Procurement of Forty Two (42) Units Junior Executive Chair with Arm Rest for NPS Region V:

WHEREAS, Regional Prosecution Office V through the Bids and Awards Committee (BAC) posted in the PHILGEPS website, DOJ website and in conspicuous place in their office premises, and sent to suppliers of known qualifications the Request for Quotations (RFQ) for the procurement of Junior Executive Chair with Arm Rest;

WHEREAS, the submission and opening of bids was scheduled on November 24, 2020;

WHEREAS, on different dates prior to the deadline of submission of price quotations, two (2) suppliers submitted their quotations on sealed envelopes and one (1) supplier submitted the RFQ form without quotation;

WHEREAS, in the course of the evaluation of the bids by the BAC the following are the result:

Supplier	Bid Amount	Remarks
a. SL Ruiz Furniture	Php150,990.00	ELIGIBLE, compliant with the specification and eligibility requirements
b. . Legazpi Jebson Trading	Php161,700.00	INELIGIBLE, due to highest bid amount, non-compliant with the required delivery period
c. New Silahis Educational Supply	No bid indicated in the RFQ	Returned the RFQ Form without quotation


WHEREAS, upon careful review and evaluation of the documentary requirements submitted by the Bidders, the BAC determined that SL Ruiz Furniture qualified, by meeting the Approved Budget for the Contract (ABC) and complied with all the specifications and eligibility requirements;

WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Acting Head of Procuring Entity or his/her duly authorized representative.




