**RECOMMENDING AWARD OF CONTRACT FOR THE PURCHASE AND DELIVERY OF ORDINARY OFFICE SUPPLIES (CONSUMABLES) THROUGH SHOPPING UNDER SECTION 52.1(b) OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184**

**WHEREAS**, in accordance with the Guidelines for Shopping and Small Value Procurement of the Revised Implementing Rules and Regulations of RA 9184, the Regional Prosecution Office V thru its Bids and Awards Committee posted in the PHILGEPS website, DOJ website and in conspicuous place in their office premises and sent to suppliers of known qualifications the Request for Quotations (RFQ) of ordinary office supplies (consumables) not available in the DBM-PS and need to be procured;

**WHEREAS**, the submission and opening of bids was scheduled on November 24, 2020;

**WHEREAS**, five (5) suppliers submitted their quotations, namely Pixel 8 Web Solutions and Consultancy Inc., Denver's Computer Shoppe, Inc., Legazpi Jebson Trading, Ban Bee Commercial Co., Inc. and Albay Computer & Electronics Supplies & Repair;

**WHEREAS**, in the course of the evaluation of the bids by the BAC the following are the result:

| e. Albay Computer & Electronics Supplies and Repairs | Php130,818.00     | INELIGIBLE, incomplete eligibility requirements  |

**WHEREAS**, upon careful review and evaluation of the documentary requirements submitted by the Bidders, the BAC determined that Denver's Computer Shoppe, Inc. qualified, by meeting the Approved Budget for the Contract (ABC) and complied with all the specifications and


eligibility requirements of the project;

**WHEREAS**, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Acting Head of Procuring Entity or his/her duly authorized representative.

**NOW THEREFORE**, for and in consideration of the foregoing, We, the members of the RPO V-BAC, hereby **RECOMMEND** to the Acting Head of Procuring Entity, the following:

**1.) AWARD OF CONTRACT** via Shopping to Denver's Computer Shoppe, Inc. for the purchase and delivery of Ordinary Office Supplies (Consumables) in the amount of One Hundred Thirty Thousand Seven Hundred Forty Six Pesos (P130,746.00), inclusive of appropriate taxes and fees;


