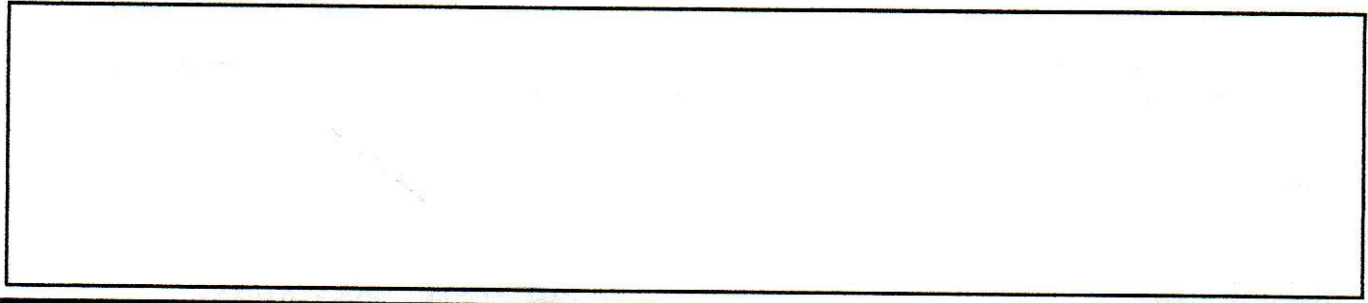

TERMS AND CONDITIONS
(Bulk Order and Catering Contract)

The following Terms and Conditions will apply to the Bulk Order and Catering (BOC) Contract detailed on the reverse side of this document.

1. Deposit/Payment

A fifty percent (50%) downpayment and a duly signed Bulk Order and Catering (BOC) Contract are required for the confirmation of the food and service orders of the CLIENT. The stipulated down payment is indicated in the reverse side of this document.

Only cash, manager's check or currently dated corporate check will be accepted as down payment. Said down payment must be paid at least seven (7) working days before the event date stipulated in the reverse side of this document. Acceptable check payments must be issued and made payable to **ROXAS FOOD VENTURES, INC.**

Payment of the balance stipulated in the reverse side of this document must be paid in cash upon the delivery of the food on the event date. If the client wishes to pay by way of check, only a manager's check or currently dated corporate check will be accepted and the same must be paid at least four (4) working days before the event date stipulated in the reverse side of this document.

Any sum due and unpaid under the Bulk Order and Catering (BOC) contract shall earn interest at the rate of three percent (3%) per month until the entire sum is fully settled. For this purpose, a delay or a fraction of a month shall be considered as one (1) month.

In the event of suit for collection, the CLIENT agrees that venue shall be the proper courts in the City of Manila to the exclusion of all other venues. Further, the Client agrees to pay **Roxas Food Ventures, Inc.**, the balance due plus stipulated interest and 25% of the amount due as liquidated damages, attorney's fees and cost of collection.

2. Additional Orders

Any additional orders should be made at least five (5) days before the event date. Additional orders must be sent via telefax duly signed by the representative of the client and is subject for confirmation by **Roxas Food Ventures, Inc.**

An additional order should be covered by the appropriate down payment that may be required by **Roxas Food Ventures, Inc.**, which shall be paid in the manner prescribed by the latter.

3. Refund/ Cancellation

Cancellation of confirmed orders must be made at least five (5) days before the event date. The cancellation must be made in writing, transmitted personally and duly received by **Roxas Food Ventures, Inc.**, at its offices. If cancellation is transmitted by telefax, it shall be considered received if duly confirmed by **Roxas Food Ventures, Inc.**, via telefax. Any cancellation done without observing the foregoing procedure shall be considered invalid and the client shall forfeit the stipulated down payment and for the full price of the balance if the food so ordered have already been prepared.

4. Liability

It is hereby mutually agreed that **Roxas Food Ventures, Inc.**, shall not be liable for damages brought about by delays or non-compliance with this Bulk Order and Catering Services contract due to strikes, accidents, power interruption, natural calamity and the like, that are beyond the control of **Roxas Food Ventures, Inc.**

It is further agreed that food products ordered by the client must be consumed within one (1) hour from the time of delivery at the event site. **Roxas Food Ventures, Inc.**, shall not be liable for any food spoilage or product quality deterioration as a result/consequence of the food product being consumed beyond one (1) hour from delivery or when the same is consumed outside of the event site.

Finally, **Roxas Food Ventures, Inc.**, shall be absolved from any liability if food provided by other suppliers or third parties are served during the event considering that it would be impossible to apportion liability in this instance.
