RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO JEMS CATERING SERVICES FOR THE PACKED MEALS IN CONNECTION WITH THE OPG YEAR-END ASSESMENT/GENERAL ASSEMBLY ON 9 DECEMBER 2020

WHEREAS, there is a need for a catering services for the packed meals in connection with the OPG year-end assessment/general assembly on 9 December 2020;

WHEREAS, the purchase of the aforementioned goods is included in the CY2020 Supplemental Annual Procurement Plan No. 1(SAPP 1);

WHEREAS, the Approved Budget for the Contract under Small Value Procurement is P100,000.00

WHEREAS, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for six (6) calendar days and was sent to three (3) prospective suppliers, namely: Jems Catering Services, Sweet Onion Cuisine and Catering Services Corp. and Shakey's Pizza Asia Ventures, Inc.;

WHEREAS, in response to the said invitation, the three (3) prospective supplier submitted their quotations, to wit,

WHEREAS, after review and evaluation, BAC-TWG found Jems Catering Services to be legally, financially, and technically capable to undertake


the subject procurement, having submitted the Lowest Calculated and Responsive Quotation (SCRQ);

WHEREAS, considering that the amount involved in the subject procurement is **NINETY THOUSAND PESOS (P90,000.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of resort to alternative mode of procurement thru Small Value Procurement, and further recommend the award of contract to **Jems Catering Services** for the catering services for the packed meals in connection with the OPG year-end assessment/general assembly on 9 December 2020 in the amount of **NINETY THOUSAND PESOS (P90,000.00)**.
