Rental of Studio To be used to host the ONLINE NPS XI YEAR-END PERFORMANCE ASSESSMENT CONFERENCE 2020

KNOW ALL MEN BY THESE PRESENTS:

This **CONTRACT** is made and executed by and between:

DEPARTMENT OF JUSTICE, REGIONAL PROSECUTION OFFICE XI, a Philippine Government entity, duly represented by **Regional Prosecutor JANET GRACE B. DALISAY-FABRERO**, of legal age, Filipino with office address at Regional Prosecution Office XI, Hall of Justice Bldg., Candelaria Avenue, Ecoland, Davao City, hereinafter referred to as the **FIRST PARTY**;

-and-

GLOBAL IMPACT PHILS FOUNDATION, INC., a Non-Profit Foundation/Advocacy/Charity company, with office address at #1 Uranus St., GSIS Subd., Brgy. Matina Crossing, Talomo District, Davao City, duly represented by **Ms. ANALOU JOY C. PANDIAN**, hereinafter referred to as the **SECOND PARTY**;

WITNESSETH

WHEREAS, the **FIRST PARTY** engaged the services of the **SECOND PARTY** for the rental of a **studio** owned and operated by the latter to be used to host the **Online National Prosecution Service XI Year-End Performance Assessment Conference 2020** on December 09, 2020;

NOW THEREFORE, for and in consideration hereof, the parties herein agreed on the following:

2. That the total **contract price** for the rental of the said studio is **Ten Thousand Pesos (Php10,000.00)**;

5. That in case of extraordinary deflation or inflation, the value of the Philippine Currency at the time of the execution of this contract shall be the basis for the settlement of account.
