## RESOLUTION

**RECOMMENDING THE AWARD OF CONTRACT TO H-ASIA  
NEWSPAPERS & MAGAZINES, INC. FOR THE SUPPLY AND DELIVERY  
OF NEWSPAPERS FOR THE USE OF THE OFFICE OF THE SECRETARY,  
COMMUNICATIONS DIVISION AND LIBRARY FOR THE PERIOD 1  
FEBRUARY 2020 TO 31 DECEMBER 2020**

**WHEREAS**, there is a need for the supply and delivery of newspapers for the use of the Office of the Secretary, Communications Division and Library for the period 1 February 2020 to 31 December 2020;

**WHEREAS**, the purchase of the aforementioned goods is included in the CY2020 Indicative Annual Procurement Plan;

**WHEREAS**, the Approved Budget for the Contract under Small Value Procurement is P330,000.00

**WHEREAS**, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for four (4) calendar days and was sent to three (3) prospective suppliers, namely: JJJ Newspapers and Magazines, Del Valle Newspaper Dealer and H-Asia Newspapers & Magazines, Inc.;

**WHEREAS**, in response to the said invitation, two (2) prospective suppliers submitted their quotations, to wit,

**WHEREAS**, after review and evaluation, the DOJ BAC-TWG found that H-ASIA NEWSPAPERS & MAGAZINES, INC. is legally, financially, and

technically capable to undertake the subject procurement, and for having submitted the Single Calculated and Responsive Quotation (SCRQ);


**WHEREAS**, considering that the amount involved in the subject procurement is **TWO HUNDRED FORTY THOUSAND FIVE HUNDRED EIGHT PESOS (P240,508.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

**NOW, THEREFORE**, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of Small Value Procurement as an alternative mode of procurement, and the award of contract to **H-ASIA NEWSPAPERS & MAGAZINES, INC.** for the supply and delivery of newspapers for the use of the Office of the Secretary, Communications Division and Library for the period 1 February 2020 to 31 December 2020 in the amount of **TWO HUNDRED FORTY THOUSAND FIVE HUNDRED EIGHT PESOS (P240,508.00)**.




