Digital Art Contest

Theme:" Peace is the Work of Justice"

MECHANICS

Background

As part of the Philippines-United Nations Joint Program on Human Rights and in observance of National Human Rights Consciousness Week, the Department of Justice (DOJ), through the Administrative Order No. 35 Secretariat (AO 35 Secretariat), is spearheading the conduct of a Human Rights Summit on 07, 09, and 10 December, 2020 with the theme "Peace is the Work of Justice".

The theme is taken from the Latin phrase on the DOJ seal, *Justitiae Pax Opus*. Properly translated, its true significance comes to the fore, raising our consciousness of justice, and necessarily human rights, as factors of peace. The theme suggests that justice, at work and accessible to all, brings peaceful, inclusive societies and ensures sustainable development.

An ancillary activity to the Summit is a Digital Art Contest which the DOJ is launching in accordance with the theme. This contest aims to raise awareness for the protection and promotion of human rights as well as challenge the imagination and showcase the creative abilities of law students as future advocates, through the use of digital ICT devices and software applications.

In light of the new normal and to encourage participation across the country, the entire competition process will be done online – from submission of entries to judging and final announcement of winners.

All entries may be used by the Department in various Public Relations applications, exhibitions, reports and activities. Intellectual property rights of winning entries shall be vested by the artist in the DOJ, for similar and other lawful use.

Eligibility

The contest is open to all Filipino Law Students currently enrolled in a duly accredited law school in the Philippines. Contestants must submit original creative digital output inspired by the theme.





Requirements:

- Submission of duly accomplished Entry Form and Declaration and Artist Release Form¹ which may be downloaded from the DOJ Official Website (https://www.doj.gov.ph/index.html);
- 2. A clear scanned copy of a valid identification document or card with signature;
- 3. A scanned copy of the law student's official school registration/enrollment form for the current semester.

No submissions from groups or companies will be accepted. Family members or relatives up to the second degree of consanguinity of any of the DOJ HR Summit 2020 organizers are likewise excluded from joining the competition.

All entries must be original, unpublished artwork not previously entered in any other competition or contest.

Only one entry per student is allowed.

Entry Specifications

- 1. All entries must be created using digital technology and must be presented in stand-alone print image format such as computer-generated painting.
- 2. Digitalized scanned hand-drawn or painted art forms will not be accepted.
- 3. Similarly, animated works, motion graphics, and other sub-classification of digital art that cannot be rendered to print will not be accepted.
- 4. Entries submitted must be in A4 proportion (8.3 x 11.7 in.), portrait orientation, high resolution JPEG format, 300 dpi.
- 5. Inclusion of promotional advertisements and inappropriate content (e.g. promotion of brands, malicious and immoral contents offending sex, race, and religion) in the artwork is strictly prohibited.
- 6. The file name of the image should follow this format:

SURNAME, FIRST NAME date submitted (ex. DELA CRUZ, JUAN 01Dec2020)

7. The deadline for submission of entries is on Sunday, 06 December 2020 at 11:59 PM.

- 8. Entries must be submitted with documentary requirements as email attachments or a google drive link to hrsummit2k20@gmail.com. Further inquiries on the Contest may be referred to the Secretariat through the same email address or phone call at (02) 8524-5936.
- 9. The Department reserves the right to reject submissions with incomplete requirements and/or details.

Intellectual Property

- 1. All submitted entries must be the contestant's original and unpublished work.
- Entries with any element infringing upon intellectual property rights of any other person, organization, corporation or other creative source will be disqualified.
- 3. By submitting an entry, the contestant affirms and warrants that no violation of trademark or copyright laws was made.
- 4. All winning entries shall become the sole property of the DOJ and may be used for any lawful purpose relevant to its mandate and/or related to cultural and advocacy promotion, but not for any economic gain or commercial use. The creators of winning entries shall be duly acknowledged at all times.
- 5. Unsuccessful entries may be used by the DOJ for exhibits, public relations purposes and reports without compensation or need for further consent.
- 6. The artists may use or reproduce their winning entries only upon prior, express written consent of the DOJ.
- 7. The submission of an entry constitutes permission for DOJ to use the contestant's name, school and details relating to the submitted art without need for further consent.

DOJ shall not be responsible for any lost, late, corrupted, misdirected, incomplete, illegible or unusable entries including those which are not submitted or received due to poor internet connectivity or other factors of *force majeure*.

Should a declared winner be found to have violated any of the rules/guidelines set forth or made any wrongful or erroneous statement, the award shall be forfeited and the prize money returned.





Criteria for Selection of Winners

- 1. The winners will be selected by a panel of evaluators to be constituted by the Summit Committee, whose decision shall be final.
- 2. Cash prizes will be awarded to the following:

1st Place - Php15,000 2nd Place - Php10,000 3rd Place - Php7,000

Three (3) consolation prizes of Php3,000 each

3. All entries will be judged based on the following criteria:

Concept and Relevance to the Theme - 35%
Originality - 30%
Creative Impact - 35%

Total - 100%

4. The winners will be announced during the closing ceremony of the HR Summit on 10 December 2020.
