## **RESOLUTION**

**WHEREAS**, Central Book Supply, Inc. submitted a quotation for the purchase of various books listed above in the total amount of One Hundred One Thousand Seven Hundred Eighty Pesos (₱ 101,780.00);

**NOW THEREFORE**, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the confirmation of resort to alternative mode of procurement thru direct contracting, and further recommend the award of contract for the purchase of various books for the DOJ Library to **CENTRAL BOOK SUPPLY, INC.**, as the exclusive publisher and distributor of SCRA, eSCRA, and all books that will



be purchased from their company, in the total amount of **ONE HUNDRED ONE THOUSAND SEVEN HUNDRED EIGHTY PESOS (P 101,780.00)**, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
