## **RESOLUTION**

### **RECOMMENDING THE AWARD OF CONTRACT TO POWER HOUSE PEST CONTROL SERVICES FOR THE SANITATION/ DISINFECTION OF DEPARTMENT OF JUSTICE OFFICES**

**WHEREAS**, there is a need for the procurement of sanitation/disinfection services for the main office of the Department of Justice (DOJ) to prevent the spread of the COVID 19 virus;

**WHEREAS**, the Invitation to Bid (ITB) for the afore-mentioned project was re-posted in the DOJ and PhilGEPS website, and in a conspicuous place in the Department's premises for more than seven (7) calendar days starting 07 May 2021;

**WHEREAS**, the procurement of this project is included in the CY 2021 Annual Procurement Plan (APP) with an Approved Budget for the Contract of Nine Hundred Fifty-Seven Thousand Eight Hundred Seven Pesos (₱ 957,807.00);

**WHEREAS**, in response to the said ITB, the following prospective bidders submitted bids with the corresponding amount stated below and were subject to bid evaluation held *via* google meet on 17 May 2021, at 10:00 a.m., to wit:



No. 9184 and its 2016 Revised Implementing Rules and Regulations.
