RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO STANLEY BRADLEY TRADING INC. FOR THE PURCHASE OF JACK PALLET AND HEAVY DUTY PLASTIC BLUE PALLET III

WHEREAS, there is a need for the Department of Justice (DOJ) to purchase the following items for the use of the Administrative Service:

WHEREAS, the RFQ was again re-posted on May 28, June 23, August 2, August 25, and September 14, 2021


