RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO TÜV RHEINLAND PHILIPPINES INC. FOR THE PROCUREMENT OF AN ISO CERTIFYING BODY FOR THE CONDUCT OF CERTIFICATION AND SURVEILLANCE AUDIT OF THE OFFICE FOR ALTERNATIVE DISPUTE RESOLUTION FOR ISO 9001:2015 QMS STANDARDS
