**RECOMMENDING AWARD OF CONTRACT FOR THE OFFICE REPAIR, RENOVATION, AND MAINTENANCE OF CITY PROSECUTION OFFICE OF LIGAO, INCLUDING LABOR AND MATERIALS UNDER NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT, SECTION 53.9) OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184.**

**WHEREAS**, the Department approved the budget of Six Hundred Thousand Pesos Only (P 600,000.00) for the Procurement of Office Repair, Renovation, and Maintenance of City Prosecution Office of Ligao, including Labor and Materials;

**WHEREAS**, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat posted the Request for Quotations (RFQ) in the Philippine Government Electronic Procurement System (PHILGEPS), DOJ website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

**WHEREAS**, the submission and opening of bids was scheduled on 03 November 2021;

**WHEREAS**, request for quotations from contractors/suppliers were obtained by the BAC Secretariat on different dates, attested by accomplished RFQs;

**WHEREAS**, per evaluation, bid of Rei-tech Construction and Supply is found to be within the Approved Budget for the Contract (ABC), and is compliant with the scope of work and eligibility requirements;

**WHEREAS**, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.

**NOW THEREFORE**, for and in consideration of the foregoing, We, the Members of the RPO V - BAC, hereby RECOMMEND to the Regional Prosecutor, the following:

1. **AWARD OF CONTRACT** via Small Value Procurement to Rei-tech Construction and Supply for the Procurement of Office Repair, Renovation, and Maintenance of City Prosecution Office of Ligao, including Labor and Materials, in the amount of Five Hundred Eighty-Five Thousand Pesos Only (P 585,000.00), inclusive of appropriate taxes and fees.
